## Perfect Finish Gel Frosted Rose (G083)

### Product description:

Thin-viscosity finishing gel without dispersion layer after curing. Available in transparent, various shades, and with glitter particles.

### Application instructions:

Apply a thin finishing layer of gel to the nail model and cure in a UV/LED light curing device for 60–90 seconds. Allow to cool thoroughly.

### Labeling elements:



H315 – Causes skin irritation.

H317 – May cause allergic skin reactions.

H319 – Causes serious eye irritation.

H410 – Very toxic to aquatic life with long-lasting effects.

EUH204 – Contains isocyanates. May cause allergic reactions.

P302 + P352 – IF ON SKIN: Wash with plenty of soap and water.

P305 + P351 + P338 – IF IN EYES: Rinse cautiously with water for several minutes.

Remove contact lenses, if present and easy to do. Continue rinsing.

P333 + P337 + P313 – If you feel unwell, or if you experience skin irritation, rash, or eye irritation: Call a POISON CENTER or doctor.

P280 – Wear protective gloves made of butyl rubber in accordance with EN 374 and eye protection in accordance with EN 166.

P273 – Avoid release to the environment.

P501 – Dispose of contents/container to an approved waste disposal company.

PAO - When stored correctly, it can be kept for 12 months after opening (can symbol).

Unopened in its original packaging and when stored correctly (cool, dry, protected from sunlight between 10 and 25°C), it can be kept for several years.
