All colour gels are highly pigmented, self-levelling and provide high coverage with a single application.

Application instructions:

Apply one coat of the respective colour gel to the mattified nail and cure. Then apply a second coat if necessary and cure. After curing, remove the dispersion layer with gel cleaner and apply a top coat of your choice.

Curing time UV/LED 90 sec.

Labeling Elements:



Danger
