Product description:

Medium-viscosity gel, tinted to create a French manicure or to cover minor damage to the natural nail.

Application instructions:

Apply the gel in an even layer to the natural nail, depending on the desired shade. For French manicures, leave the front edge of the nail free at the desired length and cure in a UV/LED light curing device for 60–90 seconds.

Then continue with the desired manicure, e.g., French, without removing the dispersion layer first.

Marking Element:



Attention

H317 – May cause allergic skin reactions.

P501 – Dispose of contents/container to an approved waste disposal company.

PAO - When stored correctly, it can be kept for 12 months after opening (can symbol).

Unopened in its original packaging and when stored correctly (cool, dry, protected from sunlight between 10 and 25°C), it can be kept for several years.
